4. MOST GOALS SCORED IN ALL THE MEETINGS PLAYED IN ROUND
5. DRAW

**ART.9 TIME OF RACE:**

THE COMPETITIONS TAKE PLACE IN 2 (TWO) TIMES OF 35 MINUTES EACH, EXCEPT THE SEMI-FINAL WHICH WILL LAST 25 'EACH, THE GAMES TO PLAY 11> 11 SIZE REGULATIONS ON FIELDS WITH DOORS AND USE REGULATIONS BALLS OF N° 5

**ARTICLE 10 PENALTY KICKS (as in the Semifinals):**

IF A DRAW AFTER THE TWO REGULAR HALVES SHOULD BE PERFORMED IN A PENALTY SHOOT THE MANNER PROVIDED IN RULE 7 OF THE PLAYING RULES AND THE OFFICIAL DECISIONS ;

**ART.11 EXTRA TIME:**

ONLY QUALIFY FOR FINAL 1ST AND 2ND PLACE THE DISAGREEMENT OF TWO EXTRA TIME OF 10 MINUTES EACH IN THE CASE OF GENDER END OF REGULATION TIME, STILL A DRAW AFTER THE TWO EXTRA TIME TO DETERMINE THE WINNER SHOULD BE PERFORMED IN A PENALTY SHOOT .10 AS ART

**ART.12 REFEREES:**

THE MATCHES WILL BE REFEREED BY F.I.G.C. / A.I.A.

**ART. 13 COMMITTEE OF THE TOURNAMENT:**

**ART.15 AUTOMATIC PENALTIES:**

AUTOMATIC PENALTIES QUALIFY WITH THE FOLLOWING TERMS: THE PLAYER EXPELLED DURING A GAME WILL NOT PARTICIPATE IN THE NEXT EVENT UNLESS MORE SANCTIONS IMPOSED BY THE NATIONAL SPORTS, THE PLAYER DURING THE TOURNAMENT A SECOND CAUTION WILL BE DISQUALIFIED FOR A RACE DECLARATION OF SPORTS COURT.

**ART.16 CLAIMS:**

ANY CLAIMS MUST BE SUBMITTED WITHIN 30 MINUTES AFTER THE END OF COMPETITION ACCOMPANIED BY THE FEE OF EURO 50; COPY OF THE COMPLAINT MUST BE DELIVERED TO THE COUNTERPART IN TERMS OF 30 MINUTES.

**ART. 17 INSURANCE:**

THE ORGANIZER IS RESPONSIBLE FOR THE REGULARITY COVER INSURANCE
